1 – BEHAVIOUR	5 10 15	AFTER SCHOOL DETENTION – PARENTS NOTIFIED VIA EMAIL TEACHER MEETING WITH PARENTS MANAGEMENT MEETING WITH PARENTS
2 - GENERAL	5 10 15	AFTER SCHOOL DETENTION – PARENTS NOTIFIED VIA EMAIL MANAGEMENT MEETING WITH PARENTS FORMAL DISCIPLINARY PROCEEDINGS WHERE NECESSARY
3 - GENERAL	30	THE SCHOOL WILL DETERMINE THE NATURE OF THE CONSEQUENCES DEPENDENT ON THE OFFENSE COMMITTED. THIS MAY INCLUDE A DISCIPLINARY HEARING WHICH COULD RESULT IN SUSPENSION AND/OR EXPULSION
